Adult Program Director and Coordinator of Career Planning Service, Special Assistant to the President for Equal Opportunity Programs and Director of Human Resources at Drake University, the founder of the Governor's Commission on the Status of Women, and chair of the second attempt in Iowa to pass the ERA.

Betty died in 2018. We join with her family and many friends and associates in recognizing and celebrating Betty's many accomplishments.
