AAUW Guidelines on Philanthropy

With the addition of the word philanthropy to our AAUW mission statement, our national organization has devoted much time and thought to the discussion of legally complying with IRS rules concerning our financial support of non-profit, non-AAUW activities.

Ames AAUW member Diane Patton has served on the committee that has developed the policy, which is extensive and not all new.

Basically, our Des Moines Branch, which has a 501(c)(4) tax status, supported by our national AAUW, is affected in the following way. Our funds, as always, can support any AAUW scholarships, funds, and activities. We can support, with our participation, activities and events of our own, and other non-profit organizations, in line with our mission. But to give our financial support to non-AAUW activities, funds, and scholarships, we must work in a collaborative process where we have representation in the goal setting and decision-making process.

Certainly our support with suppers, clothes, and help with the Christmas party of the Young Women's Resource Center is in compliance. The Lois Dell Child Development scholarship at DMACC, which we have supported, was carefully drawn up to give the DMACC Foundation clear and acceptable guidelines for its use, over which we are kept informed. This also would be in compliance. Certainly our support with suppers, clothes, and help with the Christmas party of the Young Women's Resource Center is in compliance.

Other major aspects of the policy relate to fundraising, and contributors' expectations for tax deductibility, and are spelled out on the AAUW website.

Seven women will be running for state leadership positions and national legislative seats in the November 4 general election. There will be 11 Iowa Senate and 37 House candidates who are women on the ballot. That's progress in a state ranked near the bottom in the proportion of women holding public office.

AAUW does not endorse specific candidates, nor does the 50/50 in 2020 campaign. But we certainly support all women's right to run!
